# CHARITY NOMINATION GUIDELINES

Our mission is to reach causes which drive impactful, positive change, primarily on a local level. We recognize that many charitable organizations are in need of support, and we're excited to learn about and uplift both familiar non-profits and those new to us.

Before each meeting, three nonprofits will be randomly selected from our nomination pool to present to the full membership. After hearing from each organization, members will vote and the nonprofit receiving the most votes will be awarded our collective donation. The two nonprofits not selected will each receive a minimum donation of \$500 and are welcome to resubmit their nomination for future consideration. Just as important, every organization that presents at our Member Meetings will gain valuable visibility among the members of 100 Women Who Care / TVR.

## GUIDELINES

Charities can be nominated by any Member.

To nominate a non-profit, Members must be in good standing including:

- Having a current, signed Membership & Commitment form
- Be current with donations.

Eligibility Requirements:

- To be a potential recipient an organization must meet all the following criteria:
  - Be recognized by the IRS as a 501c3 non-profit organization.
  - Spend 70% of our contribution for the benefit of the people of Rio Verde, Fountain Hills, Cave Creek, Carefree, Scottsdale and Phoenix. Local chapters of national Non-profit will be considered if 70% of the contribution stays in our communities.
  - Have the ability to provide tax receipts to each donor.
  - Be in existence for a minimum of one year.
  - Agree not to create, sell, or distribute a list with our members' contact information, and agree not to solicit our members directly for future contributions.
  - Agree to recognize the TVR Chapter of 100 Women Who Care on social media, collateral, etc.
  - If possible, the non-profit will attend the meeting to represent the non-profit by delivering a 5-minute casual presentation + Q&A. If this is not possible, the member who nominated will present on their behalf. The chosen non-profit will also be asked to return at our next meeting to briefly speak about how the donations were used.
  - The following are ineligible for funding: religious groups promoting religious activities, political organizations, organizations operating to support a single individual, organizations with a non-charitable purpose, and organizations which discriminate against individuals on the basis of creed, color, sexual orientation, age, gender, national origin, or veteran status.
- In addition:
  - 100+ Women Who Care TVR Members can only nominate one non-profit at a time.
  - There is no limit on the number of members who can nominate a particular charity but it will only be officially submitted once.
  - The non-profit selected to receive the donation, can be re-submitted in two (2) years.
  - Non-profits that does not win can be re-submitted at any time.
